



**2025-2026 Tuition Rates & Fees**  
***Incoming Students***

Infants/ Ones: \$1075/ monthly

Pre-K 2: \$1025/ monthly

Pre-K 3 & Pre-K 4: \$975/monthly

Family Discount: \$25/monthly for each additional child.

*(Tuition Rates will be based on the child's age as of 9/30 of the current academic year)*

Initial Registration Fee (New Families): \$250

Annual Supply Fee: \$200

## **2025-2026 Financial Assistance**

We encourage you to apply for any financial assistance you may qualify for. Carousel Preschool currently accepts the following Financial Assistance Programs:

[Child Care Assistance Program](#)- Child Care Assistance (CCAP) is offered directly through the Louisiana Department of Education and covers all or a portion of our tuition fees for families whose income is 85% or less than the State Median Income (SMI) and meets certain eligibility requirements. The income eligibility has recently changed and families who may not have qualified before may qualify now. For assistance applying, please contact [Kim Jones](#) or Yesenia Mendoza with Jefferson Parish Early Childhood Network.

[Preschool Development Grant \(B-3\)](#)- This is a program funded for children 3 years old and younger currently offered through the Jefferson Parish Ready Start Network to Jefferson Parish residents. This is an income based program that will allow families a free childcare seat. Families who qualify for a B-3 seat will receive funding assistance to cover any tuition costs during the Academic year. (Please note: full tuition charges will be due during the Summer months). *As of March 2025, this program is expected to transition to the Louisiana Department of Education. Please contact us to request information when more information is available.*

Military Families: Carousel also accepts financial assistance for military families through [Child Care Aware](#) and [NAVY CYP!](#)

Flexible Spending Accounts (FSA): Carousel Preschool does qualify as an approved childcare service for FSA accounts through your employer. We can provide monthly receipts as requested by your employer, or you can access your statements anytime by visiting [myprocare.com](http://myprocare.com) using your email address on file to login.

Weekly Payment Plans: Carousel Preschool will offer the financing option to break monthly fees so weekly payments will be available to a limited number of families on an as needed basis, depending on availability. These fees will be due each week of the year including in the event of closure. In this instance, payments will be broken down based on 4.33 weeks per month and rounded up to include a small processing fee. **Infants & Ones = \$250/wk, Pre-K 2 = 240/week, Pre-K 3 & 4 = \$228/week**
